7.1 Precautions for safe handling

Never inhale this substance. Prevent the accumulation of electrostatic charges with connections to earth. Use the mixture in premises free of naked flames or other sources of ignition and ensure that electrical equipment is suitably protected. Keep packages tightly closed and away from sources of heat, sparks and naked flames. Do not use tools which may produce sparks. Do not smoke. Prevent access by unauthorised personnel.
