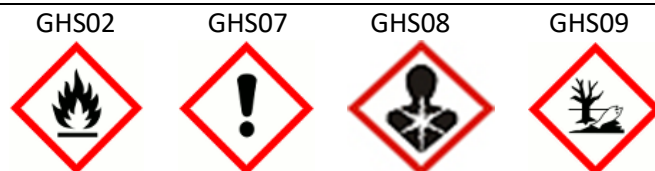

### 04. FIRST AID MEASURES

<b>4.1 Description of first aid measures</b>	
Inhalation	Remove immediately from source of exposure to fresh air. Get medical attention if any discomfort continues.
Ingestion	Do not give the patient anything orally. In the event of swallowing, if the quantity is small (no more than one mouthful), rinse the mouth with water and consult a doctor. Seek medical attention immediately, showing the label. If swallowed accidentally, do not allow to drink, do not induce vomiting and transfer to hospital immediately by ambulance. Show the label to the doctor.

Skin Contact	Remove contaminated clothing and wash the skin thoroughly with soap and water or a recognised cleaner. Watch out for any remaining product between skin and clothing, watches, shoes, etc. In the event of an allergic reaction, seek medical attention. If the contaminated area is widespread and/or there is damage to the skin, a doctor must be consulted or the patient transferred to hospital.
Eye Contact	Immediately flush with plenty of water for up to 15 minutes. Remove any contact lenses and open eyes wide apart. Get medical attention immediately. Continue to rinse.

<b>6.2 Environmental Precautions</b>	Contain and control the leaks or spills with non-combustible absorbent materials such as sand, earth, vermiculite, diatomaceous earth in drums for waste disposal. Prevent any material from entering drains or waterways. If the product contaminates waterways, rivers or drains, alert the relevant authorities in accordance with statutory procedures. <b>6.3 Methods and material for containment and cleaning up.</b>	Cover with an inert, inorganic, non-combustible absorbent material (e.g dry-lime, sand, soda ash). Place in covered containers using non-sparking tools and transport outdoors. Avoid open flames or sources of ignition. Ventilate area and wash spill site after material pickup is complete. ## 07. HANDLING AND STORAGE

### 7.1 Precautions for safe handling

Requirements relating to storage premises apply to all facilities where the substance is handled. Individuals with a history of skin sensitisation should not, under any circumstance, handle this substance. Always wash hands after handling. Remove and wash contaminated clothing before re-using. Remove contaminated clothing and protective equipment before entering eating areas.

#### Fire prevention:

Handle in well-ventilated areas. Prevent the formation of flammable or explosive concentrations in air and avoid vapour concentrations higher than the occupational exposure limits. Never inhale this substance. Prevent the accumulation of electrostatic charges with connections to earth. Use the mixture in premises free of naked flames or other sources of ignition and ensure that electrical equipment is suitably protected. Keep packages tightly closed and away from sources of heat, sparks and naked flames. Do not use tools which may produce sparks. Do not smoke. Prevent access by unauthorised personnel.

Keep the container tightly closed in a dry, well-ventilated place. Keep away from food and drink, including those for animals. Keep away from all sources of ignition - do not smoke. Keep well away from all sources of ignition, heat and direct sunlight. Avoid accumulation of electrostatic charges.

Always keep in packaging made of an identical material to the original.
