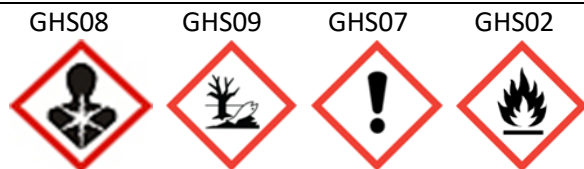

04. FIRST AID MEASURES

4.1 Description of first aid measures

Inhalation	Remove victim immediately from source of exposure. Get medical attention if any discomfort continues.
Ingestion	Do not give the patient anything orally. In the event of swallowing, if the quantity is small (no more than one mouthful), rinse the mouth with water and consult a doctor. Use the mixture in premises free of naked flames or other sources of ignition and ensure that electrical equipment is suitably protected.
